Professor -Aristotle University Thessaloniki

Eugenia Prevedourou is Professor of Administrative Law at the School of Law of the Aristotle University of Thessaloniki. She was born in Patra and she studied Law at the National and Kapodistrian University of Athens. (1986).

In March 1988 she pursued her postgraduate studies at the University PARIS II (Université de Droit, d'Économie et de Sciences Sociales de Paris) and she obtained the DEA (Diplôme d'études approfondies) in Public Law (1988) and the DEA in Community Law (1989).

After her doctoral studies under the supervision of Professor Yves Gaudemet, also in Paris, she was awarded the title of Doctor of Laws of the University Paris II, in October 1994. The doctoral thesis, bearing the title “Obligatory administrative appeals. Comparative study of French and German Law”, was published by LGDJ, series Bibliothèque de Droit Public (t. 180).

From 1st January 1992 until 15th October 2001, she worked as a civil servant in the Court of Justice of the European Communities. She speaks fluently French, English and German and Dutch at a satisfactory level. She is an attorney-at-law, member of the Athens Bar Association, since 1988. She is full professor since 4th July 2017.

She has been teaching at the Aristotle University of Thessaloniki Administrative Law, Administrative Procedural Law, Synthesis of Public Law and at the post-graduate studies programme (Direction of Public Law and Political Science) Administrative Law. She participated in the post-graduate studies programme entitled “Law and European Integration” of the General Law Department of the Panteion University in the context of which she taught “Civil state’s liability against infringements of European Law”. She is supervising professor of three doctoral studies one of which is realized under a “cotutelle regime” (University of Lorraine).

In February and March 2006 she taught as a visiting professor at University Paris II in the post-graduate programme Administrative Law and in February 2007, as a visiting

professor at the University of Montpellier I, Administrative Law in undergraduate studies programme.

Visiting-researcher at the French Council of State(1.10-30.11/2010) and at the Institute of Cujas(University of Paris II) (1.12.2010- 28.2.2011).

Visiting-researcher at theInstitut für Deutsches und Europäisches Verwaltungsrecht (Juristische Fakultät der Universität Heidelberg) (1.10.2014-31.12.2014)

She has also published seven monographs and a significant number of studies in several fields of Administrative Law in Greek and in French. There are references to her publications in several monographs and articles in Greece and in France.

She has realized numerous lectures and interventions in seminars, congresses and scientific events of several actors among which the Council of State, the National School of Judges, the Community of Administrative Studies, the Association of Administrative Studies, and Bar Associations.

Since the 1st of July 2008, she is member of the Appeals Board of the European University Institute of Florence. Her mandate was renewed in July 2014 for six years.

Since December 2009 she is a member of the Committee on Legal Affairs of the Aristotle University of Thessaloniki and since September 2017 she has become Vice-President. She participated in the Legislative Preparatory Committees of the Ministry of Civil Protection, of Administrative Reform and e-Government services and of the Ministry of Education.

She is also a member of the following associations: Hellenic Association of European Law, Association of Greek Constitutional experts, French Research Association of Administrative Law -SocietasJurisPubliciEuropaei (SIPE), Society of Comparative Legislation and finally treasurer of the Hellenic Society of Urban and Territorial Law. Since April 2014 she is member of the Management Board of the Society of Administrative Studies.
